Dear Discovery Link Families,

Thank you for your interest in our financial assistance program for the 17-18 school year. These scholarships are awarded on a first come, first serve basis.

As a reminder, our financial assistance process has changed this year. Please review the information below for these changes.

- All families needing assistance will be required to apply for CCAP (Colorado Child Care Assistance Program) first. If you are denied services by CCAP or put on the waitlist please submit the denial/waitlist letter to us with your financial assistance application to be eligible to apply for assistance through Discovery Link. This is a valuable resource for families and it is common throughout the state to require this.
- All families will be required to apply for financial assistance every school year even if they have previously received financial support.
- The amount of financial assistance awarded to each family will be impacted by the overall amount of available funds and may be different than in previous years.
